During prior years, the School constructed certain other buildings within its campus that were financed with interest-free loans from its Founder through the entity DEBowman LLC. During the year ended June 30, 2013, the School repaid \$100,000 of principal owed on this obligation resulting in an unpaid balance due at year-end of \$2,135,000. No specific scheduled repayment of this obligation has been established. An in-kind contribution of \$21,850 has been included in support reflected on the accompanying statement of activities with a like amount included in occupancy expense for the donated interest. This calculated amount assumes an interest rate of one percent.

Schedule L - Parts II and IV

Since its inception the School has leased its land and certain buildings located within its campus from its Founder and former member of its Board of Directors through the entity DEBowman LLC. During the year ended June 30, 2013, the school made lease payments of \$134,580. The balance owed to the above entity for all unpaid lease obligations from prior periods, as of June 30, 2013, is \$642,220. No specific scheduled repayment of this obligation has been established.

Payments due under the terms of the lease are calculated based on a \$12 per square foot fair market value of the buildings used in the operation of the School. During the year the School leased buildings consisting of 11,215 square feet; therefore, the amount due for the year ended June 30, 2013 was \$134,580.
